AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Cathleen Nine-Altevogt, and Tameri Melendez ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance ("Commissioner").

WHEREAS, Respondent is a licensed Indiana nonresident insurance producer, holding license number 942281;

WHEREAS, Respondent obtained her nonresident Indiana insurance producer license with qualifications for Life, Accident and Health lines of authority on March 26, 2014;

WHEREAS, on or about April 14, 2016, the Respondent submitted notice of administrative actions taken against her in the states of Florida and New York;

WHEREAS, the Respondent failed to notify the Department within thirty (30) days of the final disposition of the April 25, 2014 license denial by the Florida Department of Financial

Services for failing to disclose a 2009 Felony conviction for Possession of Marijuana on her application for licensure;

WHEREAS, the Respondent's conduct is a violation of Indiana Code § 27-1-15.6-17(a), which states that a producer shall report to the Commissioner any administrative action taken against the producer not more than thirty (30) days after the final disposition of the matter;

WHEREAS, Respondent is subject to administrative action in accordance with Indiana Code § 27-1-15.6-12(b)(2)(A), which authorizes the Commissioner to levy a civil penalty against a producer for violating an insurance law;

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent shall pay an administrative fine in the amount of two hundred fifty dollars (\$250) within thirty (30) days after the Commissioner signs the Final Order adopting this Agreed Entry.
- 6. The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.

- 7. Respondent has carefully read and examined this agreement and fully understands its terms.
- 8. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.
- 9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 10. Respondent is aware that failure to comply with any of the terms of this agreement will result in the matter being set for a hearing.
