IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- Respondent agrees to pay an administrative penalty in the amount of five hundred dollars (\$500) to the Department within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
- 6. The Department agrees to accept Respondent's compliance with the Agreed Entry herein as full satisfaction of this matter.
- 7. Respondent has carefully read and examined this Agreed Entry and fully understands its terms.
- 8. Respondent has entered into this Agreed Entry freely, and has not been subject to duress, threat or undue influence.
- 9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall

not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

10. Respondent is aware that failure to comply with any term of this agreement will result in the matter being set for hearing.
