# AGREED ENTRY

This Agreed Entry is executed by the Indiana Department of Insurance ("Department"), by counsel, Cathleen Nine-Altevogt, and First American Title, ("Respondent"), a title insurance agency licensed to do business in Indiana, to resolve all issues in the above captioned matter. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner, Indiana Department of Insurance ("Commissioner").

WHEREAS, Respondent is a resident title insurance agency licensed in the State of Indiana, holding license number 1299930; and

WHEREAS, Indiana Code §§ 27-7-3.7-4(5); 27-7-3.7-7 requires that personal checks not exceed five hundred dollars (\$500) by an agency and an agency may not accept cashier checks that exceed ten thousand dollars (\$10,000);

WHEREAS, Respondent has failed to adhere to the Good Funds Law and accepted and deposited seventy (70) personal checks that exceeded five hundred dollars (\$500) and nine (9) cashier checks that exceeded ten thousand dollars (\$10,000);

WHEREAS, James Nelson, Deputy General Counsel of Operations for First American Title is authorized to act on behalf of Respondent and obligate it to perform in accordance with this agreement;

WHEREAS, the Department and Respondent desire to resolve their differences and settle their issues without incurring the time and expense of a hearing;

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and Respondent in this administrative action.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing in this matter.
- Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent agrees to pay an administrative penalty in the amount of one thousand dollars (\$1,000) to the Department within thirty (30) days of the Commissioner's Final Order adopting this Agreed Entry.
- 6. Nothing in this Agreed Entry will be deemed or asserted to be an admission by First American Title or evidence of any liability and/or wrongdoing.
- 7. The Department agrees to accept Respondent's compliance with the agreement herein as full satisfaction of this matter.

- 8. Respondent has carefully read and examined this agreement and fully understands its terms.
- 9. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.
- 10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 11. Respondent is aware that failure to comply with any term of this agreement will result in the matter being set for hearing.
