**ADMINISTRATIVE ORDER**  
**NOTICE OF NONRENEWAL OF LICENSE**

The Indiana Department of Insurance ("Department"), pursuant to Indiana Code § 4-21.5  
~~et seq., and Indiana Code § 27-1-15.6-12,~~ hereby gives notice to Gordon Adamson,  
("Respondent") of the following Administrative Order:

1. Respondent is a licensed resident insurance producer, holding license number 418804 since April 19, 2002.
2. On or about May 24, 2016, FINRA barred Respondent from association with any FINRA member in any capacity thereby revoking his licensure.
3. Respondent violated FINRA rule 9552(h) by failing to respond to a FINRA request for information.
4. The request was due to a previously unreported 2006 bankruptcy. Respondent failed to provide FINRA with any information about the bankruptcy.

5. Respondent was provided multiple attempts to resolve the issue of failing to report the FINRA regulatory action through an Agreed Entry with the IDOI. However, Respondent failed to reply to the request.

6. Pursuant to Indiana Code § 27-1-15.6-17(a), a producer shall report to the Commissioner any administrative action taken against the producer in another jurisdiction not more than thirty (30) days after the final disposition of the matter.


7. Pursuant to Indiana Code § 27-1-15.6-12 (b)(2)(a), the Commissioner may refuse to renew an insurance producer's license for violating an insurance law, Indiana Code § 27-1-15.6-17(a) is an insurance law.

8. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.

9. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, , the Commissioner of Insurance hereby notifies Respondent that **his license shall not be renewed** for having been barred from FINRA and failure to report that administrative action to the Department.
