FINAL ORDER

The Indiana Department of Insurance (“Department”), by counsel, Cathleen Nine-
Altevogt, and Elissa Stafford (“Respondent”), a licensed resident Indiana insurance producer,
signed an Agreed Entry which purports to resolve all issues involved in the action by the
Department regarding Respondent’s license, and which has been submitted to the Commissioner
of Insurance (“Commissioner”) for approval.


The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly
and without fraud, duress or undue influence, and is fair and equitable between the parties. The
Commissioner hereby incorporates the Agreed Entry as if fully set forth herein, and approves
and adopts in full the Agreed Entry as a resolution of this matter.

IT IS THEREFORE ORDERED by the Commissioner of Insurance:

1. Respondent’s resident insurance producer license number 425540 shall be
permanently revoked, effective immediately, in accordance with Indiana Code § 27-1-15.6-

12(b)(8), for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Cathleen Nine-Altevogt, and Respondent Elissa Stafford (“Respondent”), an Indiana resident insurance producer. This Agreed Entry is subject to the review and approval of the Commissioner of the Department.

WHEREAS, Respondent is a resident of Indiana;

WHEREAS, Respondent is a licensed Indiana resident insurance producer, holding license number 485262;

WHEREAS, Respondent obtained the producer license with qualifications for Property and Casualty lines of authority on August 29, 2002;

WHEREAS, Respondent obtained the qualification for a Life line of authority on April 21, 2014;

WHEREAS, Respondent submitted several life insurance applications to Grange Life Insurance Company without consumer consent containing bogus information and forged applicant signatures as uncovered by Grange's internal investigation and reported to the Department;

WHEREAS, the Department alleges Respondent's conduct is fraudulent, demonstrating incompetence and untrustworthiness in the conduct of business and is subject to administrative action in accordance with Indiana Code § 27-1-15.6-12(b)(8);

WHEREAS, the Department and Respondent desire to settle the issues without a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

1. The Commissioner has jurisdiction over the subject matter of and the parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the parties.
3. Respondent voluntarily and freely waives the right to a public hearing.
4. Respondent voluntarily and freely waives the right to petition for judicial review of this agreement and the Commissioner's Final Order.
5. Respondent's insurance producer license number 425540 shall be permanently revoked effective immediately on the date of the Commissioner's Final Order in this matter.
6. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of this matter.
7. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that

presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

8. Respondent has carefully read and examined this agreement and fully understands its terms.
