ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to Indiana Code § 4-21.5 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Jamarr Mayes, ("Respondent") of the following Administrative Order:

- 1. Respondent is a licensed nonresident insurance producer holding license number 907851 since September 11, 2013.
 - 2. Respondent's license expired on July 31, 2016.
- 3. The Department received notification from the Respondent that his producer license was denied in the State of California on January 5, 2015, his license was denied in the State of Virginia on October 23, 2013, and his license in the State of Wisconsin was denied on October 23, 2013 all of these denials were based on Respondent's criminal history.

- 4. Pursuant to Indiana Code § 27-1-15.6-12 (b)(9), the Commissioner may refuse to renew an insurance producer's license for having an insurance producer's license or its equivalent denied, suspended or revoked in any other state.
- 5. According to the National Association of Insurance Commissioners ("NAIC") Respondent had an administrative action taken on July 1, 2014 in the State of North Carolina which Respondent failed to report to Department, and Respondent had an administrative action taken in the State of Louisiana on January 21, 2014 which was not reported to the Department within the proper time frame.
- 6. Pursuant to Indiana Code § 27-1-15.6-17(a), a producer shall report to the Commissioner any administrative action taken against the producer in another jurisdiction not more than thirty (30) days after the final disposition of the matter.
- 7. Pursuant to Indiana Code § 27-1-15.6-12 (b)(2)(A), the Commissioner may refuse to renew an insurance producer's license for violating an insurance law. Indiana Code § 27-1-15.6-17(a) is an insurance law.
- 8. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.
- 9. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that his license shall not be renewed for having had licenses denied in other states and for his failure to report administrative actions to the Department.
