2. Respondent is hereby fined \$1000, due within thirty (30) after the signing of this Final Order, in accordance with Indiana Code § 27-1-15.6-12(a), for violations of Indiana Code § 27-1-15.6-12(b)(8), as evidenced by Respondent submitting a life insurance policy for a deceased individual,

## AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Cathleen Nine-Altevogt, and Respondent, Sarah J. Sauer ("Respondent"), an Indiana resident insurance producer. This Agreed Entry is subject to the review and approval of the Commissioner of the Department.

WHEREAS, Respondent is a licensed Indiana resident insurance producer, holding license number 1658630;

WHEREAS, Respondent obtained the producer license with qualifications for Life, Accident and Health lines of authority on March 22, 1980 and a Property and Casualty line of authority on June 12, 1982;

WHEREAS, on or about December 3, 2015, Respondent submitted an application to Transamerica Insurance, in order to obtain life insurance coverage for Harold Johnson, Sr. ("Mr.

Johnson"), who had asked Respondent to hold his application while he considered his coverage options;

WHEREAS, Mr. Johnson died on September 22, 2015; nearly three (3) months prior to the submission of the life insurance application by the Respondent;

WHEREAS, Respondent also received instructions from Howard Johnson in December, 2015 to hold his application and Respondent confused Howard Johnson with the pending application from Harold Johnson.

WHEREAS, Respondent did not discover that she had submitted an application for insurance for Harold Johnson, the wrong client, until after the application had been submitted;

WHEREAS, Respondent's submission of a deceased person's application for a policy of life insurance is fraudulent, demonstrating incompetence and untrustworthiness in the conduct of business and is subject to administrative action in accordance with Indiana Code § 27-1-15.6-12(b)(8);

WHEREAS, the Department and Respondent desire to settle the issues without a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter of and the parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing.
- 4. Respondent voluntarily and freely waives the right to petition for judicial review of this agreement and the Commissioner's Final Order.

5. Respondent's Indiana insurance producer license number 1658630 shall be placed on probationary status as defined in Indiana Code § 27-1-15.6-12(a), effective on the date of the Commissioner's Final Order in this matter.

6. Respondent shall pay an administrative fine of \$1000.

7. The Department agrees to accept Respondent's compliance with the terms of this agreement as full resolution of this matter.

8. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.

9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

10. Respondent is aware that failure to comply with any of the terms of this agreement will result in the matter being set for a hearing.

11. Respondent has carefully read and examined this agreement and fully understands its terms.
