FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Jessie J. Bible ("Respondent") is a nonresident insurance producer under license # 1036059.

WHEREAS, Indiana Code § 27-1-15.6-12(g) states that a licensed producer must furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding not more than (10) days after a request.

WHEREAS, on January 06, 2017, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a certified letter requesting a list of appointments to an address on record for Respondent.

WHEREAS, on January 17, 2017, certified mail article # 7005 3110 0002 4442 5158 was returned marked as "not deliverable as addressed" by the United States Postal Service ("USPS").

WHEREAS, on January 20, 2017, the Commissioner resent the January 06, 2017 request for a list of appointments to Respondent via email to an email address on record for Respondent.

WHEREAS, the January 20, 2017 email included a request for a "delivery receipt." A delivery receipt was received by the Department that same day, indicating that the email to Respondent was successfully delivered.


WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as requested by the Commissioner.

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g).

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license # 1036059 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
