AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Cathleen Nine-Altevogt, and Burns Insurance Agency Inc. ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of the Department's Commissioner, Stephen W. Robertson ("Commissioner");

WHEREAS, Respondent is a licensed resident producer organization, holding license number 935479;

WHEREAS, on February 14, 2014, Respondent submitted an application for licensure, which was approved.

WHEREAS, on said application, Respondent failed to disclose that on October 08, 2009 Respondent's owner, Shane S. Burns, had been convicted of misdemeanor theft;

WHEREAS, the resident producer license of Shane S. Burns, number 600030, was revoked on June 23, 2016 for his failure to timely notify his criminal proceedings to the Department;

WHEREAS, the Respondent's actions are in violation of Indiana Code § 27-1-15.6-12(b)(1), which states that an applicant shall not provide incorrect, misleading, incomplete, or materially untrue information in a license application;

WHEREAS, Eric A. Harrison is authorized to act on behalf of Respondent and obligate it to perform in accordance with this agreement;

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent shall pay an administrative fine of Two Hundred Fifty Dollars (\$250) within thirty (30) days after the Commissioner signs the Final Order adopting this Agreed Entry.

- Respondent acknowledges that the resident producer license of Shane S. Burns, number 600030, is revoked.
- 7. Respondent acknowledges that Shane S. Burns shall not sell, solicit, or negotiate insurance products unless he obtains proper licensure.
- 8. Respondent acknowledges that no commissions earned by Respondent or Respondent's employees shall be shared with Shane S. Burns.
- Should additional violations manifest, further administrative actions will be taken for the new violation.
- 10. The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.
- 11. Respondent has carefully read and examined this agreement and fully understands and accepts its terms.
- 12. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.

- Should this Agreed Entry not be accepted by the Commissioner, it is agreed that 13. presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 14. Respondent is aware that failure to comply with any terms of this agreement will result in the matter being set for a hearing.
