**ADMINISTRATIVE ORDER**  
**NOTICE OF NONRENEWAL OF LICENSE**

The Indiana Department of Insurance (“Department”), pursuant to Indiana Code § 4-21.5 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Duane Thompson Jr., (“Respondent”) of the following Administrative Order:

1. Respondent is a licensed resident insurance producer holding license number 975003 since August 28, 2014.
2. Respondent’s license expired on January 31, 2017.
3. The Department received notification that Respondent was convicted on November 3, 2016 in Monroe County, Indiana of level 6 Felony Auto Theft.
4. Pursuant to Indiana Code § 27-1-15.6-12(b)(6), the Commissioner may refuse to renew an insurance producer’s license for having been convicted of a felony.


5. Pursuant to Indiana Code § 27-1-15.6-17(b), the Commissioner may refuse to renew an insurance producer's license for failing to report within thirty (30) days after an initial pretrial hearing date any criminal prosecution of the producer initiated in any jurisdiction.

6. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.

7. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **his license shall not be renewed** for having a level 6 felony conviction in Monroe County, Indiana, and failing to report it to the Commissioner within thirty (30) days of the initial pretrial hearing date.
