ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Rhonda Butler ("Respondent") of the following Administrative Order:

- 1. Respondent is a licensed resident insurance producer holding license number 387886.
 - 2. Respondent's license expired on February 28, 2017.
- 3. On March 14, 2017, Respondent submitted a Marion County Superior Court
 Sentencing Order dated June 28, 2016, stating that the Respondent has been convicted of a Level
 6 Felony Operating a Vehicle While Intoxicated: Endangering a Person.
- 4. Pursuant to Indiana Code § 27-1-15.6-12(b)(6), the Commissioner may refuse to renew an insurance producer's license for having been convicted of a felony.

5. Pursuant to Indiana Code § 27-1-15.6-17(b), the Commissioner may refuse to

renew an insurance producer's license for failing to report within thirty (30) days after an initial

pretrial hearing date any criminal prosecution of the producer initiated in any jurisdiction.

6. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of

the reason for the nonrenewal of her license. This Order serves as that notice.

7. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-

1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a

written demand upon the Commissioner for a hearing to determine the reasonableness of this

action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's

written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies

Respondent that her license shall not be renewed for having had a felony conviction in Marion

County, Indiana, and failing to report it to the Commissioner within thirty (30) days of the initial

pretrial hearing date.
