Commissioner being fully advised, now hereby notifies Applicant that he has not fully

met the requirements of licensure as stated by Indiana Code § 27-1-15.6-12 based on his

December 4, 2006 Indiana conviction of Class A Misdemeanor Domestic Battery.

5. Indiana Code § 27-1-15.6-12(d) provides that the applicant may, not more than sixty-

three (63) days after notice of denial of the applicant's application is mailed, make

written demand to the Commissioner for a hearing before the Commissioner to determine

the reasonableness of the Commissioner's action.

IT IS THEREFORE ORDERED that the Applicant's request for licensure is hereby

DENIED pursuant to Indiana Code §27-1-15.6-12(b).
