ADMINISTRATIVE ORDER
NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Ryan M. Herndon, (“Respondent”) of the following Administrative Order:

1. Respondent, a resident of Indiana, is a licensed insurance producer holding license number 443275 since September 24, 2014 (“Respondent’s license”).
2. Respondent’s license expired on February 28, 2017.
3. On or about December 15, 2014, the Enforcement Division of the Indiana Department of Insurance (“Enforcement Division”) received notification that Respondent had pending August 02, 2012 charges of Welfare Fraud, a Class C Felony, and False Informing, a Class A Misdemeanor.
4. Respondent submitted an application for licensure on September 24, 2014.

5. Respondent failed to disclose his pending criminal charges on his license application.

6. Pursuant to Indiana Code § 27-1-15.6-12(b)(1), the Commissioner may refuse to renew an insurance producer license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.

7. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.

8. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **his license shall not be renewed** for his failure to disclose his criminal proceedings in an application for licensure.
