## ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Chandra Barr, ("Respondent") of the following Administrative Order:

- 1. Respondent, a nonresident of Indiana, is a licensed insurance producer holding license number 982531 since September 22, 2014 ("Respondent's license").
  - 2. Respondent's license is set to expire on August 31, 2017.
- 3. On or about December 15, 2016 the Enforcement Division of the Indiana Department of Insurance ("Enforcement Division") received notification that Respondent was terminated for cause from Allstate Insurance Company due to falsification of three (3) applications for insurance.
- 4. On March 06, 2017 Respondent's license was revoked by the Commissioner of Insurance of the State of Kansas.

- 5. Respondent failed to timely disclose the administrative action to the Department.
- 6. Pursuant to Indiana Code § 27-1-15.6-12(b)(8), the Commissioner may refuse to renew an insurance producer license for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere.
- 7. Pursuant to Indiana Code § 27-1-15.6-12(b)(9), the Commissioner may refuse to renew an insurance producer's license for having an insurance producer's license or its equivalent, denied, suspended, or revoked in any other state, province, district or territory.
- 8. Pursuant to Indiana Code § 27-1-15.6-12(b)(2)(A), the Commissioner may refuse to renew an insurance producer's license for violating an insurance law. Indiana Code § 27-1-15.6-17(a) is an insurance law which states that a producer shall report to the Commissioner any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition of the matter.
- 9. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of her license. This Order serves as that notice.
- 10. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **her license shall not be renewed** due to the falsification of three (3) applications for insurance and license revocation in Kansas.
