**PRELIMINARY ADMINISTRATIVE ORDER**  
**AND NOTICE OF LICENSE DENIAL**

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act §4-21.5*et seq.* and Indiana Code §27-1-28-18, hereby gives notice to Tatiana McConnico (“Applicant”) of the following Administrative Order:

1. Applicant filed an application for licensure with the Commissioner of the Indiana Department of Insurance (“Commissioner”) on March 01, 2017.
2. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code §27-1-28-16 and Indiana Code §27-1-28-18.
3. Indiana Code §27-1-28-18(b)(8) provides that the Commissioner may refuse to issue an independent adjusters license for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility, in the conduct of insurance business.
4. Following a review of materials submitted by Applicant in support of her application, the Commissioner being fully advised, now hereby notifies Applicant that she has not fully

met the requirements of licensure as stated by Indiana Code §27-1-28-18(b)(8) due to her May 15, 2010 California conviction of Petty Theft, a Standard Misdemeanor.

6. Indiana Code §27-1-28-18(c) provides that the applicant or licensee may, not more than thirty (30) days after receiving the Commissioner's notice of refusal, make written demand upon the commissioner for a hearing to determine the reasonableness of the refusal.

**IT IS THEREFORE ORDERED** that Applicant's request for licensure is hereby DENIED pursuant to Indiana Code §27-1-28-18(b)(8) due to her misdemeanor conviction of petty theft.
