ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to Indiana Code § 4-21.5 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Autumn Bradney, ("Respondent") of the following Administrative Order:

- 1. Respondent is a licensed resident insurance producer, holding license number 898504 since August 23, 2013.
- 2. On or about February 16, 2017 Respondent, while attempting to renew her producer license, answered "Yes" to the question on the renewal application "have you been convicted of a misdemeanor, had judgement withheld or deferred, or are you currently charged with committing a misdemeanor, which has not been previously reported to this insurance department?"
- 3. On the February 16, 2017 application submission, Respondent answered she would submit a written statement explaining the circumstance of each incident; however, after multiple attempts to contact Respondent she failed to submit a written statement.

4. Pursuant to Indiana Code § 27-1-15.6-12(b)(1), the Commissioner may refuse to renew an insurance producer license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.

5. Pursuant to Indiana Code § 27-1-15.6-17(b), the producer shall report to the Commissioner any criminal prosecution of the producer not more than thirty (30) days after an initial pretrial hearing.

6. Pursuant to Indiana Code § 27-1-15.6-12(b)(2)(A), the Commissioner may refuse to renew an insurance producer's license for violating an insurance law; Indiana Code § 27-1-15.6-17(b) is an insurance law.

7. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of her license. This Order serves as that notice.

8. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, the Commissioner of Insurance hereby notifies Respondent that her license shall not be renewed for having failed to report a criminal conviction to the Department and failing to provide a complete license application for a producer license renewal.
