ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to Indiana Code § 4-21.5 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Devan Sieg, ("Respondent") of the following Administrative Order:

- 1. Respondent is a licensed resident insurance producer, holding license number 968822 since August 6, 2014
- 2. On or about April 4, 2017, Respondent attempted to renew her producer license, where it was brought to the Department's attention that Respondent failed to report multiple convictions.
 - 3. Respondent's resident producer license is due to expire on May 31, 2017.
 - 4. Respondent failed to report the following criminal convictions to the Department:
 - July 21, 2016- Class A Misdemeanor Resisting Law Enforcement, Class B
 Misdemeanor Criminal Mischief

- April 23, 2015- Level D Felony Obtaining or Attempting to Obtain Legend
 Drugs by Fraud
- April 23, 2015- Level D Felony Possession of a Controlled Substance, Class B
 Misdemeanor Battery
- April 23, 2015- Level D Felony Operating a Vehicle While Intoxicated
- April 25, 2013- Class C Misdemeanor Operating a Vehicle with ACE of .08 or More
- 5. Pursuant to Indiana Code § 27-1-15.6-12(b)(6), the Commissioner may refuse to renew an insurance producer license for having been convicted of a felony.
- 6. Pursuant to Indiana Code § 27-1-15.6-12(b)(8), the Commissioner may refuse to renew an insurance producer license for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere.
- 7. Pursuant to Indiana Code § 27-1-15.6-17(b), the producer shall report to the Commissioner any criminal prosecution of the producer not more than thirty (30) days after an initial pretrial hearing.
- 8. Pursuant to Indiana Code § 27-1-15.6-12(b)(2)(A), the Commissioner may refuse to renew an insurance producer's license for violating an insurance law; Indiana Code § 27-1-15.6-17(b) is an insurance law.
- 9. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.
- 10. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a

written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, the Commissioner of Insurance hereby notifies Respondent that her license shall not be renewed for having failed to report multiple felony and misdemeanor convictions.
