ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Lourdes Gonzalez ("Respondent") of the following Administrative Order:

- 1. Respondent is a licensed nonresident insurance producer holding license number 415577.
 - 2. Respondent's license expired on April 30, 2017.
- 3. On June 2, 2016, Respondent was convicted of a Misdemeanor- Driving While Intoxicated in Texas.
- 4. The Department first received notice of this conviction when Respondent applied to renew her license on April 10, 2017.
- 5. Pursuant to Indiana Code § 27-1-15.6-12(b)(2)(A), the Commissioner may refuse to renew an insurance producer's license for violating an insurance law. Indiana Code § 27-1-15.6-

17(b) is an insurance law that requires the producer to report any criminal proceedings to the

Commissioner not more than thirty (30) days after an initial pretrial hearing date.

6. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of

the reason for the nonrenewal of her license. This Order serves as that notice.

7. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-

1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a

written demand upon the Commissioner for a hearing to determine the reasonableness of this

action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's

written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies

Respondent that her license shall not be renewed for having failed to timely report a criminal

proceeding to the Commissioner.
