PRELIMINARY ADMINISTRATIVE ORDER
AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code §4-21.5 *et seq.* and Indiana Code §27-1-15.6-12, hereby gives notice to Casandra Watson ("Applicant") of the following Administrative Order:

1. Applicant filed an application for resident licensure with the Commissioner of the Indiana Department of Insurance ("Commissioner") on April 20, 2017.
2. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code §27-1-15.6-6 and Indiana Code §27-1-15.6-12.
3. Indiana Code §27-1-15.6-12(b) provides, in part, that the Commissioner may refuse to issue or renew an insurance producer license for providing incorrect, misleading, incomplete, or materially untrue information in a license application, and when an insurance producer license has been denied, suspended, or revoked in any other state, province, district, or territory.
4. Following a review of materials submitted by Applicant in support of their application, the Commissioner being fully advised, now hereby notifies Applicant that she has not fully

met the requirements of licensure as stated by Indiana Code §27-1-15.6-12(b)(1) and Indiana Code §27-1-15.6-12(b)(9) because of the following administrative actions she failed to reveal on her license application: a December 2, 2015 Order of License Suspension by the Office of Commissioner of Insurance State of Georgia; a November 21, 2015 Order of Revocation by the Commissioner of Insurance of the State of Kansas; a August 30, 2016 Order of Summary Revocation by the State of California Department of Insurance; and a December 16, 2016 Order Revoking License by the Commonwealth of Virginia State Corporation Commission.

5. Indiana Code §27-1-15.6-12(d) provides that the applicant may, not more than sixty-three (63) days after notice of denial of the application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.

IT IS THEREFORE ORDERED that Applicant's request for licensure is hereby DENIED pursuant to Indiana Code §27-1-15.6-12(b) for failing to disclose four (4) administrative actions in an application for licensure pursuant to Indiana Code §27-1-15.6-12(b)(1) and for having had her license denied, suspended or revoked in four (4) states pursuant to Indiana Code §27-1-15.6-12(b)(9) .
