ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Daniel Goff ("Respondent") of the following Administrative Order:

- 1. Respondent was a licensed resident insurance producer holding license number 574843.
 - 2. Respondent's license expired on May 31, 2015.
 - 3. On January 27, 2017, Respondent applied to reactivate his expired license.
- 4. On February 5, 2015, the Respondent was convicted of Felony Operating While Intoxicated ("OWI") in Allen County, Indiana.
- 5. On February 11, 2015, Respondent was convicted in Allen County of a Level 6
 Felony Forgery With Intent to Defraud related to transmitting a document to the court in his
 OWI case.

6. Pursuant to Indiana Code § 27-1-15.6-12(b)(6), the Commissioner may refuse to renew an insurance producer's license for having been convicted of a felony.

7. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.

8. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that his license shall not be renewed for having felony convictions in Allen County, Indiana.
