**PRELIMINARY ADMINISTRATIVE ORDER
AND NOTICE OF LICENSE DENIAL**

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code §4-21.5-1 *et seq.* and Indiana Code §27-1-15.6-12, hereby gives notice to Vetinsure LLC (“Applicant”) of the following Administrative Order:

1. Applicant filed an application for nonresident licensure with the Commissioner of the Indiana Department of Insurance (“Commissioner”) on May 25, 2017.
2. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code §27-1-15.6-8 and Indiana Code §27-1-15.6-12.
3. Indiana Code §27-1-15.6-12(b) provides, in part, that the Commissioner may refuse to issue or renew an insurance producer license for providing incorrect, misleading, incomplete, or materially untrue information in a license application, and for having an insurance producer’s license or its equivalent, denied, suspended, or revoked in any other state, province, district or territory.
4. Following a review of materials submitted by Applicant in support of their application, the Commissioner being fully advised, now hereby notifies Applicant that they have not fully

met the requirements of licensure as stated by Indiana Code §27-1-15.6-12(b)(9) due to their August 29, 2012 license denial by the Wisconsin Office of the Commissioner of Insurance and their November 14, 2016 license denial by the Indiana Department of Insurance (“IDOI”); and Indiana Code §27-1-15.6-12(b)(1) due to their failure to disclose the IDOI license denial on their application for Indiana licensure.

5. Indiana Code §27-1-15.6-12(d) provides that the applicant may, not more than sixty-three (63) days after notice of denial of the application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner’s action.

IT IS THEREFORE ORDERED that Applicant’s request for licensure is hereby DENIED pursuant to Indiana Code §27-1-15.6-12(b) for having two (2) insurance producer’s licenses denied and for failing to disclose an administrative action on their license application.
