WHEREAS, Respondent was terminated for cause from Bankers Life and Casualty Insurance Company due to the submission of two (2) life insurance applications with false information;

WHEREAS, Respondent's actions are in violation of Indiana Code § 27-1-15.6-12(b)(8), which states that a producer shall not use fraudulent, coercive, or dishonest practices, or

demonstrate incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere;

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the Parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent agrees to the permanent revocation of his resident producer license.
- Should additional violations manifest, further administrative actions will be taken for the new violation.
- 7. The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.
- Respondent has carefully read and examined this agreement and fully understands and accepts its terms.
- Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.
- Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall
