PRELIMINARY ADMINISTRATIVE ORDER AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to James David Wilkins ("Applicant") of the following Administrative Order:

- 1. Applicant submitted an application for licensure with the Commissioner of the Indiana Department of Insurance ("Commissioner") on May 23, 2017.
- 2. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code § 27-1-15.6-8 and Indiana Code § 27-1-15.6-12.
- 3. Indiana Code § 27-1-15.6-12(b)(1) states that the Commissioner may deny a license application for providing incorrect, misleading, incomplete, or materially untrue information on a license application.
- 4. Indiana Code § 27-1-15.6-12(b)(9) states that the Commissioner may deny a license application for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.

5. Following a review of materials which were submitted in the application, the Commissioner being fully advised, now hereby notifies Applicant that they have not fully met the requirements of licensure as stated by Indiana Code § 27-1-15.6-12(b)(1) and Indiana Code § 27-1-15.6-12(b)(9), for having a license revoked in the State of Virginia on August 30, 2012, for failing to report the Virginia revocation, and for failing to report an administrative action taken in the State of Ohio on March 1, 2012.

6. Indiana Code § 27-1-15.6-12(d) provides that the Applicant may, not more than sixty-three (63) days after notice of denial of the Applicant's application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.

IT IS THEREFORE ORDERED that Applicant's request for licensure is hereby DENIED pursuant to Indiana Code § 27-1-15.6-12(b)(1) and Indiana Code § 27-1-15.6-12(b)(9), due to having a producer license revoked in another state and failing to report the revocation and an administrative action on the application for licensure.
