ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to Indiana Code § 4-21.5 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Anthony Mikalauskas, ("Respondent") of the following Administrative Order:

- 1. Respondent is a licensed nonresident insurance producer, holding license number 884382 since June 7, 2013.
 - 2. Respondent's license became inactive as of April 30, 2016 for the failure to renew.
- 3. On August 12, 2016, Respondent's license was revoked in the state of Virginia for misrepresenting benefits of an insurance policy, by making fraudulent statements or representations in an insurance application for the purpose of obtaining a fee, commission, money or other benefit from an insurer.

- 4. On or about July 12, 2017 the Department was notified of Respondent's termination for cause from Guarantee Trust Life Insurance Company for submitting a life insurance policy application and withdrawing funds from a client without permission.
- 5. Pursuant to Indiana Code § 27-1-15.6-12(b)(8), the Commissioner may refuse to renew an insurance producer license for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere.
- 6. Pursuant to Indiana Code § 27-1-15.6-12(b)(9), the Commissioner may refuse to renew an insurance producer license for having an insurance license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.
- 7. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.
- 8. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, the Commissioner of Insurance hereby notifies Respondent that his license shall not be renewed for having a license revocation and for using fraudulent, coercive, or dishonest practices in the conduct of business.
