ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to Indiana Code § 4-21.5-1 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Hope Mansfield, ("Respondent") of the following Administrative Order:

- Respondent is a licensed resident producer holding license number 994181 since
 October 27, 2014 ("Respondent's license").
 - 2. Respondent's license expired on September 30, 2017.
- 3. On or about September 15, 2016, the Enforcement Division of the Indiana
 Department of Insurance ("Enforcement Division") received notification that on June 15, 2016
 Respondent was charged with Battery Resulting in Bodily Injury, a Class A Misdemeanor and
 Strangulation, a Level 6 Felony.
 - 4. Respondent attended the initial pretrial hearing of her case on June 21, 2016.
 - 5. On November 01, 2017 Respondent was convicted of both charges.

- 6. Indiana Code § 27-1-15.6-17(b) is a law which states not more than thirty (30) days after an initial pretrial hearing date, a producer shall report to the Commissioner any criminal prosecution of the producer initiated in any jurisdiction.
- 7. Pursuant to Indiana Code § 27-1-15.6-12(b)(2)(A) the Commissioner may refuse to renew an insurance producer's license for violating an insurance law.
- 8. Pursuant to Indiana Code § 27-1-15.6-12(b)(6) the Commissioner may refuse to renew an insurance producer's license for having been convicted of a felony.
- 9. Pursuant to Indiana Code § 27-1-15.6-12(b)(8) the Commissioner may refuse to renew an insurance producer's license for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness or financial irresponsibility in the conduct of business in Indiana or elsewhere.
- 10. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of her license. This Order serves as that notice.
- 11. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **her license shall not be renewed** due her failure to timely report her criminal proceedings to the Department and for having been convicted of a felony.
