FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Angelita C. Woods ("Respondent") is a nonresident insurance producer under license # 3228532.

WHEREAS, Indiana Code § 27-1-15.6-12(g) states that a licensed producer must furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding not more than (10) days after a request.

WHEREAS, on November 27, 2017, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a certified letter requesting a list of appointments.

WHEREAS, on December 04, 2017, certified mail article # 7016 2140 0000 9009 3631 was returned by the United States Postal Service ("USPS") marked as "return to sender."

WHEREAS, on December 05, 2017, the Commissioner resent the November 27, 2017 request for a list of appointments to Respondent via email to an email address on record for Respondent.

WHEREAS, the December 05, 2017 email included a request for a "delivery receipt." A delivery receipt was received by the Department that same day, indicating that the email to Respondent was successfully delivered.

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as required under Indiana Code § 27-1-15.6-12(g).

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license # 3228532 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
