PRELIMINARY ADMINISTRATIVE ORDER AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to Michele K. Moran ("Applicant") of the following Administrative Order:

- Applicant filed an application for resident licensure with the Commissioner of the Indiana
 Department of Insurance ("Commissioner") on June 28, 2017.
- 2. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code § 27-1-15.6-6 and Indiana Code § 27-1-15.6-12.
- 3. Indiana Code § 27-1-15.6-12(b) provides, in part, that the Commissioner may refuse to issue an insurance producer license for using fraudulent, coercive, or dishonest practices, or demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere, and for providing incorrect, misleading, incomplete, or materially untrue information in a license application.
- 4. Following a review of materials submitted by Applicant in support of their application, the Commissioner being fully advised, now hereby notifies Applicant that she has not fully

met the requirements of licensure as stated by Indiana Code § 27-1-15.6-12(b)(8) due to her April 03, 1995 conviction of Theft, a Class A Misdemeanor, and Indiana Code § 27-1-15.6-12(b)(1) for her failure to disclose her conviction on her application for licensure.

5. Indiana Code § 27-1-15.6-12(d) provides that the applicant may, not more than sixty-three (63) days after notice of denial of the application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.

IT IS THEREFORE ORDERED that Applicant's request for licensure is hereby DENIED pursuant to Indiana Code § 27-1-15.6-12(b)(8) due to her misdemeanor conviction of theft and § 27-1-15.6-12(b)(1) for her failure to disclose her conviction on her application to licensure.
