**FINAL ORDER**

The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Claire Szpara, and Sylvia Wright (“Respondent”), a licensed resident insurance producer, signed an Agreed Entry which purports to resolve all issues involved in the above-captioned cause number, and which has been submitted to the Commissioner of the Indiana Department of Insurance ( “Commissioner”) for approval.

The Commissioner, after reviewing the Agreed Entry, finds it has been entered into fairly and without fraud, duress or undue influence, and is fair and equitable between the parties. IT IS THEREFORE ORDERED by the Commissioner as follows:

1. Respondents' license will be placed on probation for a period of one (1) year during which time any violations of Title 27 will result in the Department seeking immediate revocation of Respondent's license.
2. The Department agrees to accept this agreement as full resolution of this matter.

**AGREED ENTRY**

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Claire Szpara, and Sylvia Wright (“Respondent”) to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance (“Commissioner”).

WHEREAS, on July 24, 2017, Respondent applied for an Indiana nonresident producer’s license under application number 599454;

WHEREAS, Respondent disclosed a felony conviction of unemployment compensation fraud on September 17, 1996 in Broward County, Florida;

WHEREAS, Indiana Code §27-1-15.6-12(b)(6) states the Commissioner may deny a license application for having been convicted of a felony;

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the Parties as follows:

1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
2. This Agreed Entry is executed voluntarily by the Parties.
3. Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
4. Respondent voluntarily and freely waives the right to judicial review of this matter.
5. Respondents' license will be placed on probation for a period of one (1) year during which time any violations of Title 27 will result in the Department seeking immediate revocation of Respondent's license,
6. Should additional violations manifest, this revocation shall be in addition to any administrative actions for the new violation.
7. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to, and consideration of this Agreed Entry by the Commissioner, shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
8. Respondent is aware that failure to comply with any of the terms of this agreement will result in the matter being set for a hearing.
