## PRELIMINARY ADMINISTRATIVE ORDER AND NOTICE OF CERTIFICATION DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code §4-21.5-1 *et seq.* and Indiana Code §27-19-4, hereby gives notice to Christine Crowder ("Applicant") of the following Administrative Order:

- 1. Applicant filed an application for navigator certification with the Commissioner of the Indiana Department of Insurance ("Commissioner") on August 15, 2017.
- 2. Before approving an application, the Commissioner must find that the Applicant has met specific requirements under Indiana Code §27-19-4-3 and Indiana Code §27-19-4-5.
- 3. Following a review of materials submitted by Applicant in support of her application, the Commissioner being fully advised, now hereby notifies Applicant that she has not fully met the requirements of certification as stated by Indiana Code §27-19-4-3(a)(8) due to a March 20, 2014 Class C Felony Theft conviction, a September 22, 2017 Felony Four Burglary conviction, and a September 22, 2017 Class A Misdemeanor Theft conviction.
- 4. Pursuant to Indiana Code § 4-21.5-3-7, should Applicant wish for the Commissioner to review this decision, Applicant must, within fifteen (15) days after receiving notice of this

Order, file a written petition with the Commissioner. This petition must state facts demonstrating that Applicant:

- (A) is a person to whom this Order is specifically directed;
- (B) is aggrieved or adversely affected by this Order; or
- (C) is entitled to review under any law.
- 5. If a petition for review is granted, the Department shall assign the matter to an administrative law judge to conduct informal proceedings to settle the matter.

IT IS THEREFORE ORDERED that the Applicant's request for navigator certification is hereby

DENIED due to her March 20, 2014 Class C Felony Theft conviction, September 22, 2017 Felony Four Burglary conviction, and September 22, 2017 Class A Misdemeanor Theft conviction.
