ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-28-18, hereby gives notice to Stephen P. Harmon, ("Respondent") of the following Administrative Order:

- Respondent is a licensed nonresident independent adjuster holding license number
 1003714 since December 05, 2014 ("Respondent's license"). Respondent's home state is
 Mississippi.
 - 2. Respondent's license expired on September 30, 2017.
- 3. On or about October 23, 2017, the Enforcement Division of the Indiana Department of Insurance ("Enforcement Division") received notification that in Mississippi Respondent has the following criminal history: on February 01, 2001, Respondent was convicted of misdemeanor criminal contempt; on May 31, 2001, he was convicted of misdemeanor trespass; and on October 29, 2001, he was convicted of misdemeanor simple worthless check.

4. Respondent's misdemeanor convictions were not disclosed on his initial application for licensure.

5. Pursuant to Indiana Code § 27-1-28-18(b)(1), the Commissioner may refuse to renew an independent adjuster's license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.

6. Indiana Code § 27-1-28-18(c) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.

7. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-28-18(c), Respondent may, not more than thirty (30) days after receiving the commissioner's notice of refusal, make written demand upon the commissioner for a hearing to determine the reasonableness of that refusal.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies
Respondent that his license shall not be renewed due his failure to disclose his criminal history
on an application for licensure.
