PRELIMINARY ADMINISTRATIVE ORDER
AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to Noel G. Thomas (“Applicant”) of the following Administrative Order:

1. Applicant filed an application for nonresident licensure with the Commissioner of the Indiana Department of Insurance (“Commissioner”) on October 10, 2017.
2. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code § 27-1-15.6-8 and Indiana Code § 27-1-15.6-12.
3. Indiana Code § 27-1-15.6-12(b)(9) provides that the Commissioner may refuse to issue an insurance producer license for having an insurance producer’s license or its equivalent, denied, suspended, or revoked in any other state, province, district or territory.
4. Indiana Code § 27-1-15.6-12(b)(1) provides that the Commissioner may refuse to issue an insurance producer license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.

5. Following a review of materials submitted by Applicant in support of his application, the Commissioner being fully advised, now hereby notifies Applicant that he has not fully met the requirements of licensure as stated by Indiana Code § 27-1-15.6-12(b)(9) due to a March 19, 2015 license revocation by the New York Department of Financial Services; a November 04, 2015 license revocation by the Virginia Bureau of Insurance; a December 02, 2015 license revocation by the Wyoming Department of Insurance; a January 14, 2016 license revocation by the Louisiana Department of Insurance; an October 21, 2016 license revocation by the South Dakota Division of Insurance, and Indiana Code § 27-1-15.6-12(b)(1) due to his failure to disclose the administrative actions on his application for licensure.
4. Indiana Code § 27-1-15.6-12(d) provides that the applicant may, not more than sixty-three (63) days after notice of denial of the application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.

IT IS THEREFORE ORDERED that Applicant's request for licensure is hereby DENIED pursuant to Indiana Code § 27-1-15.6-12(b)(9) and § 27-1-15.6-12(b)(1) due to his five (5) license revocations and his failure to disclose them on an application.
