PRELIMINARY ADMINISTRATIVE ORDER
AND NOTICE OF LICENSE DENIAL

The Indiana Department of Insurance, pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.* and Indiana Code § 27-1-15.6-12, hereby gives notice to Audrey Michelle Loosemore (“Applicant”) of the following Administrative Order:

1. Applicant filed an application for nonresident producer’s licensure with the Commissioner of the Indiana Department of Insurance (“Commissioner”) on November 13, 2017.
2. Before approving an application, the Commissioner must find that the applicant has met specific requirements under Indiana Code § 27-1-15.6-8 and Indiana Code § 27-1-15.6-12.
3. Indiana Code § 27-1-15.6-12(b)(6) provides that the Commissioner may refuse to issue or renew an insurance producer license due to Applicant having been convicted of a felony.
4. Indiana Code § 27-1-15.6-12(b)(8) authorizes the Commissioner to refuse to issue a producer’s license for using fraudulent, coercive, or dishonest practices, or

demonstrating incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere.

5. Following a review of materials submitted by Applicant in support of her application, the Commissioner being fully advised, now hereby notifies Applicant that she has not fully met the requirements of licensure as stated by Indiana Code § 27-1-15.6-12(b)(6), due to her four (4) Utah felony convictions, as follows:
 - a. January 26, 1995 3rd Degree Felony, possession of a controlled substance
 - b. March 9, 1995 3rd Degree Felony, larceny
 - c. August 28, 1995 3rd Degree Felony, possession of a controlled substance
 - d. November 24, 2003 3rd Degree Felony, assault


6. The Commissioner being fully advised, now hereby also notifies Applicant that she has not fully met the requirements of licensure as stated by Indiana Code § 27-1-15.6-12(b)(8), due to her four (4) Utah misdemeanor convictions, as follows:
 - a. August 19, 1993 Class B Misdemeanor, theft
 - b. January 11, 1994 Class B Misdemeanor, theft
 - c. March 1, 1995 Class B Misdemeanor, possession of narcotic equipment
 - d. March 9, 1995 Class B Misdemeanor, possession of narcotic equipment

7. Indiana Code § 27-1-15.6-12(d) provides that the Applicant may, not more than sixty-three (63) days after notice of denial of the applicant's application is mailed, make written demand to the Commissioner for a hearing before the Commissioner to determine the reasonableness of the Commissioner's action.

IT IS THEREFORE ORDERED that the Applicant's request for licensure is hereby DENIED pursuant to Indiana Codes §§ 27-1-15.6-12(b)(6) and 27-1-15.6-12(b)(8), due to having multiple felony and misdemeanor convictions.
