FINAL ORDER

1. Respondent shall be placed on probation for a period of two (2) years beginning

upon the issuance of the Final Order; during the probationary period, any violations

of Title 27 of the Indiana Code will result in the Department seeking immediate

revocation of Applicant's license.

2. Respondent shall pay an administrative penalty in the amount of five hundred

dollars (\$500) dollars within thirty (30) days after the Commissioner signs the Final

Order.

3. The Department agrees to accept this agreement as full resolution of this matter.

AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel, Erica J. Dobbs, and Antionette Randles ("Respondent") to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance ("Commissioner").

WHEREAS, Respondent applied for a nonresident producer license on October 26, 2015, which was approved;

WHEREAS, the Department was made aware on or about January 8, 2018 that Respondent failed to report a felony Attempted Larceny conviction on her application for licensure on October 26, 2015;

WHEREAS, Indiana Code § 27-1-15.6-12(b)(1) states, in part, the Commissioner may levy a civil penalty and place an insurance producer on probation for providing incorrect, misleading, incomplete, or materially untrue information in an application for licensure;

WHEREAS, Indiana Code § 27-1-15.6-12(b)(6) states, in part, the Commissioner may levy a civil penalty and place an insurance producer on probation for having been convicted of a felony; and

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the Parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent's license will be placed on probation for a period of two (2) years, during which time any violations of Title 27 of the Indiana Code will result in the Department seeking immediate revocation of Applicant's license.
- 6. The two (2) year probationary period shall begin upon the date of the issuance of the Final Order in this matter.
- 7. Respondent shall pay an administrative penalty in the amount of five hundred dollars (\$500) within thirty (30) days after the Commissioner signs the Final Order adopting this Agreed Entry.
- 8. Should additional violations manifest, this penalty shall be in addition to any administrative actions for the new violation(s).

- 9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to, and consideration of this Agreed Entry by the Commissioner, shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 8. Respondent is aware that failure to comply with any of the terms of this agreement will result in the matter being set for a hearing.
