WHEREAS, the Department and Applicant (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing;

## IT IS, THEREFORE, NOW AGREED by and between the Parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Applicant voluntarily and freely waives the right to a public hearing on the issues in this matter.
- 4. Applicant voluntarily and freely waives the right to judicial review of this matter.
- 5. Applicant's license will be placed on probation for a period of two (2) years, during which time any violations of Title 27 of the Indiana Code will result in the Department seeking immediate revocation of Applicant's license.
- 6. The two (2) year probationary period shall begin upon the date of the issuance of the Final Order in this matter
- 7. Should additional violations manifest, this probation shall be in addition to any administrative actions for the new violation(s).
- 8. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to, and consideration of this Agreed Entry by the Commissioner, shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 8. Applicant is aware that failure to comply with any of the terms of this agreement will result in the matter being set for a hearing.
