WHEREAS, Indiana Code § 27-1-15.6-12(b)(6) states, in part, that the Commissioner may place an insurance producer on probation for having been convicted of a felony;

WHEREAS, the Department and Applicant (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the Parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- Applicant voluntarily and freely waives the right to a public hearing on the issues in this matter.
- 4. Applicant voluntarily and freely waives the right to judicial review of this matter.
- 5. Applicant's Indiana nonresident license shall be granted and placed on probation for a period of two (2) years, during which time any violations of Title 27 of the Indiana Code will result in the Department seeking immediate revocation of Applicant's license.
- 6. The two (2) year probationary period shall begin upon the date of the issuance of the Final Order in this matter.
- The Department agrees to accept Applicant's compliance with this agreement as full satisfaction of this matter.
- Applicant has carefully read and examined this agreement and fully understands its terms.
- Applicant has entered into this agreement freely, and has not been subject to duress,
 threat or undue influence.

- Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- 10. Applicant is aware that failure to comply with any of the terms of this agreement will result in the matter being set for a hearing.
