## FINAL ORDER

- 1. Respondent shall pay a civil penalty in the amount of two hundred fifty dollars (\$250), payable within thirty (30) days from the date of this Final Order, for failing to timely report another state's administrative action in violation of Indiana Code \$27-1-15.6-12(b)(2)(A).
- 2. The Department agrees to accept this agreement as full resolution of this matter.

## AGREED ENTRY

This Agreed Entry is executed by and between the Enforcement Division of the Indiana Department of Insurance ("Department"), by counsel Erica J. Dobbs, and Northeast National Brokerage, LLC ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance ("Commissioner").

WHEREAS, Respondent is a licensed nonresident insurance producer organization, holding license number 695710;

WHEREAS, on December 7, 2017, a Consent Order by the Texas Commissioner of Insurance was filed against Respondent for failure to timely file surplus lines policies;

WHEREAS, on January 31, 2018, Respondent reported this administrative action to the Department;

WHEREAS, Indiana Code § 27-1-15.6-12(b)(2)(A), provides, in part, that the Commissioner may levy a civil penalty against a producer for violating an insurance law;

WHEREAS, Indiana Code § 27-1-15.6-17(a) is an insurance law which states a producer shall report to the commissioner any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition of the matter. The report shall include a copy of the order, consent to order, or other relevant legal documents;

WHEREAS, Jack Kramer, President and Manager of Northeast National Brokerage, LLC, is authorized to act on behalf of Respondent and obligate it to perform in accordance with this agreement; and

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

## IT IS, THEREFORE, NOW AGREED by and between the Parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent shall pay an administrative penalty of Two Hundred Fifty Dollars (\$250) within thirty (30) days after the Commissioner signs the Final Order adopting this Agreed Entry.

6. The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.

7. Respondent has carefully read and examined this agreement and fully understands its terms.

8. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.

9. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.

10. Respondent is aware that failure to comply with any of the terms of this agreement will result in the matter being set for a hearing.
