

**MOTION TO LIFT SUSPENSION**

The Indiana Department of Insurance Enforcement Division (“Department”), by counsel, Erica J. Dobbs, now moves that the Suspension Order of February 16, 2018 be lifted. In support of this request, the Department asserts the following:

1. Walter Ringfield (“Respondent”) is an individual nonresident insurance producer under license number 3177196;
2. On January 8, 2018, a letter was mailed to Respondent by regular mail via the United States Postal Services requesting a list of appointments.
3. On January 29, 2018, the Commission of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a certified letter requesting a list of appointments;
4. On February 13, 2018, certified mail article #70053110000244418266, was marked as undeliverable by the United States Postal Service;
5. More than ten (10) days had elapsed since the commissioner requested a list of appointments;

6. Pursuant to Indiana Code § 27-1-15.6-12(g), on February 16, 2018, the Commissioner issued a Suspension Order suspending Respondent's license #3177196 until such time as the Commissioner received Respondent's list of appointments;
7. On May 31, 2018, Respondent sent an email to the Department providing a list of his appointments, and is now in compliance with IC 27-1-15.6-12(g).

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license and for all other relief just and proper in the premises.

**FINDINGS OF FACT AND SUSPENSION ORDER**

WHEREAS, Walter Ringfield (“Respondent”) is a nonresident insurance producer under license number 3177196;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of a request;

WHEREAS, on January 8, 2018, a letter was mailed to Respondent by regular mail via the United States Postal Services requesting a list of appointments.

WHEREAS, on January 29, 2018, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a certified letter requesting a list of appointments;

WHEREAS, on February 13, 2018, certified mail article #70053110000244418266, was marked as undeliverable by the United States Postal Service;


WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as requested by the Commissioner;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license # 3177196 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
