MOTION TO LIFT SUSPENSION ORDER


The Indiana Department of Insurance Enforcement Division (“Department”), by counsel, Erica J. Dobbs, now moves that the Suspension Order of April 6, 2018 be lifted. In support of this request the Department asserts the following:

1. Nathan Miller (“Respondent”) is an individual nonresident insurance producer under license #3283054.
2. On March 13, 2018, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a letter requesting a list of appointments.
3. More than ten (10) days had elapsed since the Commissioner requested a list of appointments.
4. Pursuant to Indiana Code §27-1-15.6-12(g), on April 6, 2018, the Commissioner issued a Suspension Order suspending Respondent’s license # 3283054 until such a time as the Commissioner received Respondent’s list of appointments.

5. On July 12, 2018, Respondent sent an email to the Department providing a list of his appointments.

WHEREFORE, the Department requests that the Commissioner issue an order lifting the suspension of Respondent's license and all other relief just and proper upon the premise.



FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Nathan Miller (“Respondent”) is a nonresident insurance producer holding license number 3283054;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on January 29, 2018, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a letter requesting a list of appointments and a written response to a complaint received by the Department;

WHEREAS, the letter was mailed to 546 Ballough Rd., Daytona Beach, FL 32114, Respondent’s address of record with the Department;

WHEREAS, on March 13, 2018, a second letter requesting a list of appointments and a written response was mailed to the Respondent at the Respondent's address of record;

WHEREAS, neither letter was returned to the Commissioner as undeliverable;


WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 3283054 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
