#### AGREED ENTRY

Robertson, Commissioner of the Indiana Department of Insurance ("Commissioner").

WHEREAS, Respondent is a licensed nonresident insurance producer holding license number 3105820 since September 18, 2015;

WHEREAS, on or about December 14, 2015, Respondent was denied a nonresident producer license in the State of Florida due to criminal history;

WHEREAS, on or about December 21, 2015, Respondent was denied a nonresident producer license in the State of Wisconsin due to criminal history;

WHEREAS, on or about May 23, 2016, Respondent was denied a nonresident producer license in the State of Oregon for failure to disclose criminal history;

WHEREAS, Respondent failed to timely disclose the Florida, Wisconsin, and Oregon license denials to the Department as required by Indiana Code § 27-1-15.6-17(a);

WHEREAS, on April 28, 2018, Respondent signed an Agreed Entry agreeing to pay a seven hundred fifty dollar (\$750) civil penalty to resolve these violations of Indiana Code;

WHEREAS, on May 18, 2018, the Commissioner entered a Final Order accepting the Agreed Entry and imposing a seven hundred fifty dollar (\$750) civil penalty against Respondent within thirty (30) days;
