Dobbs, and Toriano Bagley ("Respondent"), to resolve all issues in the above-captioned cause number. This Agreed Entry is subject to the review and approval of Stephen W. Robertson, Commissioner of the Indiana Department of Insurance ("Commissioner").

WHEREAS, on December 11, 2017, Respondent was granted a nonresident producer's license;

WHEREAS, Respondent did not disclose any criminal history on his 2017 application for licensure;

WHEREAS, on March 19, 2018, Respondent notified the Department that he had failed to disclose an October 18, 2005 conviction for Endangering a Child, a First Class Misdemeanor, out of the State of Ohio on his application for licensure;

WHEREAS, Respondent's conduct is a violation of Indiana Code § 27-1-15.6-12(b)(1), which states that a producer shall not provide incorrect, misleading, incomplete, or materially untrue information in a license application;

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the parties as follows:

- The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on the issues in this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent shall pay an administrative penalty in the amount of two hundred fifty dollars (\$250) within thirty (30) days after the Commissioner signs the Final Order adopting this Agreed Entry.
- 6. Respondent shall be placed on probation for two (2) years, during which time any violations of Title 27 of the Indiana Code will result in the Department seeking immediate revocation of Respondent's license.
- 7. The Department agrees to accept Respondent's compliance with this agreement as full satisfaction of this matter.
- Respondent has carefully read and examined this agreement and fully understands its terms.

- 9. Respondent has entered into this agreement freely, and has not been subject to duress, threat or undue influence.
- 10. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to and consideration of this Agreed Entry by the Commissioner shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
- Respondent is aware that failure to comply with any of the terms of this agreement 11. will result in the matter being set for a hearing.
