Robertson, Commissioner of the Indiana Department of Insurance ("Commissioner").

WHEREAS, Respondent is a licensed independent adjuster using Indiana as his designated home state under license number 3192942;

WHEREAS, Respondent used study aids and/or received impermissible assistance in passing the Indiana independent adjuster licensure exam on September 28, 2016;

WHEREAS, Indiana Code § 27-1-28-18(b)(11) states the Commissioner may revoke an independent adjuster license for cheating, including improperly using notes or any other reference material, to complete an examination for an insurance license;

WHEREAS, Respondent was offered an opportunity to resolve the complaint by an agreed entry requiring him to pass the Indiana independent adjusters' exam unassisted in order to maintain his license;

WHEREAS, Respondent has advised the Indiana Department of Insurance of his decision to work outside of the insurance industry;

WHEREAS, Respondent has been advised of his right to an administrative hearing before a Department administrative law judge; and

WHEREAS, the Department and Respondent (collectively, the "Parties") desire to resolve this matter without the necessity of a hearing.

IT IS, THEREFORE, NOW AGREED by and between the Parties as follows:

- 1. The Commissioner has jurisdiction over the subject matter and the Parties to this Agreed Entry.
- 2. This Agreed Entry is executed voluntarily by the Parties.
- 3. Respondent voluntarily and freely waives the right to a public hearing on this matter.
- 4. Respondent voluntarily and freely waives the right to judicial review of this matter.
- 5. Respondent agrees to surrender all authority Respondent has to conduct insurance business in the State of Indiana, and to surrender his independent adjuster license, and he shall not reapply for an independent adjuster's license.
- 6. Should additional violations manifest, additional administrative action will be taken for the new violation(s).

- 7. Respondent has carefully read and examined this Agreed Entry and fully understands its terms.
- 8. Respondent is aware that failure to comply with any of the terms of this agreement will result in the matter being set for a hearing.
- 9. Respondent has entered into this Agreed Entry freely, and has not been subject to duress, threat, or undue influence.
- 10. The Department agrees to accept Respondent's compliance with the terms of this Agreed Entry as full satisfaction of this matter.
- 11. Should this Agreed Entry not be accepted by the Commissioner, it is agreed that presentation to, and consideration of this Agreed Entry by the Commissioner, shall not unfairly or illegally prejudice the Commissioner from further participation in or resolution of these proceedings.
