ADMINISTRATIVE ORDER
NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance (“Department”), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Kathryn Therese Rodriguez (“Respondent”) of the following Administrative Order:


1. Respondent is a licensed nonresident independent adjuster holding license number 81398 since May 30, 2012.
2. Respondent’s license expired on February 28, 2019.
3. In the course of Respondent’s employment at Sedgwick Claims Management’s office in Hoffman Estates, IL, Respondent, by her own admission, rendered impermissible assistance to coworkers while they were taking the Indiana independent adjuster’s licensing exam.
4. Indiana Code § 27-1-28-18(b)(11) prohibits using notes or any other reference material to complete an examination for an adjuster’s license.

5. Respondent's conduct in the course of her employment with Sedgwick constitutes a violation of Indiana Code § 27-1-28-18(b)(11).
6. Pursuant to Indiana Code § 27-1-28-18(a) the Commissioner may refuse to renew an independent adjuster's license for violation of Indiana Code § 27-1-28-18(b)(11).
7. Indiana Code § 27-1-28-18(c) requires the Commissioner to notify a licensee of the reason for the nonrenewal of her license. This Order serves as that notice.
8. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-28-18(c), Respondent may, within thirty (30) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within twenty (20) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **her license shall not be renewed** for having provided impermissible assistance to her coworkers at Sedgwick Claims Management's Hoffman Estates, IL office.
