ADMINISTRATIVE ORDER
NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Daniel M Jemison ("Respondent") of the following Administrative Order:

1. Respondent is a licensed nonresident insurance producer holding license number 3157977 ("Respondent's license") since May 12, 2016.
2. Respondent's license expired on January 31, 2018.
3. Respondent was denied a nonresident producer license in the State of Wisconsin on May 30, 2012 due to failing to respond to the Commissioner.
4. Respondent failed to disclose this 2012 denial on his original application for Indiana nonresident licensure.

5. Respondent was again denied a nonresident producer license in the State of Wisconsin on June 19, 2017 for failing to disclose the May 30, 2012 Wisconsin denial on his application.
6. Respondent did not disclose the 2017 denial to the Department as required.
7. Respondent submitted an application to add a licensure qualification on November 8, 2018. On said application, Respondent failed to disclose both Wisconsin license denials.
8. Indiana Code § 27-1-15.6-12(b)(1) states, in part, that the Commissioner may refuse to renew an insurance producer's license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.
9. Indiana Code § 27-1-15.6-12(b)(2)(A) states, in part, that the Commissioner may refuse to renew an insurance producer's license for violating an insurance law. Indiana Code § 27-1-15.6-17(a) is an insurance law, which states that a producer shall report to the Commissioner any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition of the matter.
10. Indiana Code § 27-1-15.6-12(b)(9) states the commissioner may refuse to renew an insurance producer license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.
11. Indiana Code § 27-1-15.6-12(d) provides that when the Commissioner refuses to renew a license, the Commissioner shall notify the Respondent, in writing, of the reasons for the nonrenewal. This Order serves as that notice.
12. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order,

make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that **Respondent's license shall not be renewed** for having two (2) license denials in another state, failing to report a 2012 license denial on his 2016 application for licensure, failing to timely report a 2017 license denial to the Department, and failing to disclose both license denials on a 2018 application to add a qualification.
