ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance, pursuant to Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code § 27-1-15.6-12, hereby gives notice to Tracyann N. Hamilton, ("Respondent") of the following Administrative Order:

- 1. Respondent is a licensed nonresident insurance producer holding license number 3179887 since August 23, 2016 ("Respondent's license").
 - 2. Respondent's license expires on February 28, 2019.
- 3. On or about November 20, 2018, the Enforcement Division of the Indiana Department of Insurance ("Enforcement Division") received notification from the National Association of Insurance Commissioners ("NAIC") that Respondent's Maryland producer's license was revoked on October 11, 2018.
- 4. Further investigation by the Enforcement Division revealed that Respondent has also been subject to the following administrative actions:

- March 18, 2018 Revocation Order by the Louisiana Department of Insurance
- January 14, 2018 Revocation Order by the Illinois Department of Insurance
- October 16, 2017 Revocation Order by the Kansas Insurance Department
- June 6, 2017 Denial Order by the Wisconsin Office of the Commissioner of Insurance
- 5. Indiana Code § 27-1-15.6-12(b)(2)(A) provides, in part, that the Commissioner may refuse to renew an Insurance producer's license for violating an insurance law. Indiana Code § 27-1-15.6-17(a), is an insurance law which states that a producer shall report to the Commissioner any administrative action taken against the producer in another jurisdiction or by another governmental agency in Indiana not more than thirty (30) days after the final disposition of the matter.
- 6. Indiana Code § 27-1-15.6-12(b)(9) provides, in part, that the Commissioner may refuse to renew a producer's license for having an insurance producer's license or its equivalent, denied, suspended, or revoked in any other state, province, district or territory.
- 7. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.
- 8. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that her license shall not be renewed due to having had a license denied and four (4) licenses revoked in other states and her failure to timely report the same to the Department.
