FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Bianca Euclide ("Respondent") is a resident insurance producer holding license # 3190942 since September 28, 2016;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer must furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on August 24, 2018, the Commissioner of the Indiana Department of Insurance ("Commissioner") mailed Respondent a letter requesting a list of appointments via USPS First Class Mail;

WHEREAS, on September 4, 2018, the letter requesting a list of appointments was returned, marked "unable to forward;"

WHEREAS, on or about August 1, 2018 the Department had contacted Respondent's last known employer who was unable to provide an alternative address for Respondent;

WHEREAS, on January 31, 2019, the Commissioner mailed Respondent a certified mail

WHEREAS, on February 19, 2019, certified mail article # 7017 0190 0000 9494 0511 was

returned to the Department as "not deliverable as addressed unable to forward";

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days

of the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days

constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the commissioner may, without

a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event

that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license

#3190942 is hereby suspended, effective immediately, and will remain suspended until

Respondent submits the list of appointments requested by the Commissioner.
