## ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 et seq., and Indiana Code § 27-1-28-18, hereby gives notice to Jessica Hendrickson ("Respondent") of the following Administrative Order:

- 1. Respondent is a licensed nonresident independent adjuster holding license number 3203426 since November 14, 2016.
- 2. Respondent's license expired on March 31, 2019.
- 3. WHEREAS, Respondent used study aids and/or received impermissible assistance in passing the independent adjuster licensure exam on November 8, 2016, at the Hoffman Estates, IL office of her employer, Sedgwick Claims Management Services.
- 4. Respondent's conduct is a violation of Indiana Code § 27-1-28-18(b)(11), which prohibits cheating, including improperly using notes or any other reference material, to complete an examination for an insurance license.

- 5. Pursuant to Indiana Code § 27-1-28-18(a) the Commissioner may refuse to renew an independent adjuster's license for violation of Indiana Code § 27-1-28-18(b)(11).
- 6. Indiana Code § 27-1-28-18(c) requires the Commissioner to notify a licensee of the reason for the nonrenewal of her license. This Order serves as that notice.
- 7. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-28-18(c), Respondent may, within thirty (30) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within twenty (20) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that her license shall not be renewed due to having received impermissible assistance in taking the Indiana independent adjuster licensing exam.
