ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana

Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 *et seq.*, and Indiana Code §

27-1-15.6-12, hereby gives notice to David Kevin Lewis ("Respondent") of the following

Administrative Order:

- 1. Respondent is a licensed resident insurance producer, holding license number 703154 since June 16, 2010.
- 2. Respondent's license will expire on December 31, 2018.
- 3. On or about February 8, 2018, Indiana Department received a complaint against Respondent for issuing a life insurance policy without the consent of the insured.
- 4. Further investigation revealed that Respondent submitted applications for life insurance for three (3) separate individuals between September, 2017 and December, 2017, each listing the same person ("Beneficiary 1") as the payer and beneficiary, and the relationship of the beneficiary to the insured as "fiancé."

- 5. The Department received documentation from the original Complainant proving that Complainant and Beneficiary 1 were divorced on or about April 9, 2009.
- 6. Indiana Code § 27-1-15.6-12(b)(8) is an insurance law that states a producer shall not use fraudulent, coercive, or dishonest practices, or demonstrate incompetence, untrustworthiness, or financial irresponsibility in the conduct of business in Indiana or elsewhere.
- 7. Indiana Code § 27-1-15.6-12(d) requires the Commissioner to notify a licensee of the reason for the nonrenewal of his license. This Order serves as that notice.
- 8. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies

Respondent that **Respondent's license shall not be renewed** due to his submission of fraudulent life insurance applications.
