MOTION TO LIFT SUSPENSION ORDER


The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Victoria Hastings, now moves that the Findings of Fact and Suspension Order issued May 3, 2019, in this matter be lifted. In support of this request, the Department asserts the following:

1. Vernon O'Neal Eskridge (“Respondent”) is a licensed resident insurance producer holding license number 3334025;
2. On March 11, 2019, the Department received notice from the Indiana Department of Child Services Child Support Bureau (“Bureau”) that Respondent is responsible for child support arrearage in the amount of \$1,192.66 under Indiana Child Support Case Number 6983977;
3. On April 12, 2019, the Commissioner entered his Findings of Fact and Probation Order pursuant to Indiana Code § 27-1-15.6-29, placing Respondent’s producer license on probationary status;
4. Thereafter, on May 3, 2019, the Commissioner entered his Findings of Fact and Suspension Order pursuant to Indiana Code § 27-1-15.6-29(b), suspending Respondent’s producer license;

5. On July 8, 2019, the Department received notice from the Bureau that Respondent has resolved his child support delinquency by paying the arrearage in full as required by Indiana Code § 27-1-15.6-29;
6. Pursuant to Indiana Code § 27-1-15.6-29(c), the Commissioner may now reinstate Respondent's license.

WHEREFORE, the Enforcement Division respectfully request the Suspension Order entered on May 3, 2019, be lifted.



FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Vernon O’Neal Eskridge (“Respondent”) is a licensed resident insurance producer holding license number 3334025 since April 24, 2018 (“Respondent’s license”);

WHEREAS, on April 12, 2019, the Commissioner entered his Findings of Fact and Probation Order (“Order”) pursuant to Indiana Code § 27-1-15.6-29, placing Respondent’s license on probationary status due to notice received from the Indiana Department of Child Services Child Support Bureau (“the Bureau”) that Respondent is delinquent on a child support obligation;

WHEREAS, written notice of the Order was mailed to Respondent at his mailing address of record on April 12, 2019, notifying Respondent that his license had been placed on probationary status, his license would be suspended twenty (20) days after the date of the Order if the child support delinquency was not addressed, and how to address the delinquency;

WHEREAS, Indiana Code § 27-1-15.6-29(b) states that if the Commissioner has not received notice from the Bureau that the delinquency has been appropriately addressed within twenty (20) days of the Order, the Commissioner SHALL suspend Respondent's license;

WHEREAS the Commissioner has not received notice from the Bureau pursuant to Indiana Code § 31-25-4-32(m) or Indiana Code § 31-25-4-34(g) that Respondent has addressed the child support delinquency as required; and

WHEREAS, twenty (20) days have elapsed since the Commissioner entered his Order.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 3334025 is hereby suspended, effective immediately.

FINDINGS OF FACT AND PROBATION ORDER

WHEREAS, Vernon O’Neal Eskridge (“Respondent”) is a licensed resident insurance producer holding license number 3334025 since April 24, 2018;

WHEREAS, on or about March 11, 2019, the Indiana Department of Insurance was notified by the Indiana Department of Child Services Child Support Bureau (the “Bureau”), that Respondent is responsible for child support arrearage in the amount of \$1,192.66 under Indiana Child Support Case Number 6983977;

WHEREAS, pursuant to Indiana Code § 27-1-15.6-29, upon receiving an order from the Bureau under Indiana Code § 31-25-4-32(i) or Indiana Code § 31-25-4-34(d), the Commissioner shall place Respondent’s producer license into probationary status;

WHEREAS, pursuant to Indiana Code § 27-1-15.6-29, the Commissioner shall send Respondent a notice that his license has been placed into probationary status;

WHEREAS, this Order serves as that notice;

WHEREAS, Respondent shall either pay the child support arrearage in full, or establish a payment plan with the Bureau to pay the arrearage, which payment plan must include an income withholding order under Indiana Code § 31-16-15-2 or Indiana Code § 31-16-15-2.5;

WHEREAS, if the Commissioner has not received notice from the Bureau under Indiana Code § 31-25-4-32(m) or Indiana Code § 31-25-4-34(g) that Respondent has addressed the delinquency within twenty (20) days after the date of this notice, the Commissioner shall suspend Respondent's license; and

WHEREAS, the Commissioner may not reinstate any license until the Commissioner receives notice from the Bureau under Indiana Code § 31-25-4-32(m) or Indiana Code § 31-25-4-34(g) that Respondent has addressed the delinquency.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 3334025 is hereby placed on probationary status, effective immediately.
