FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, William M. Hall (“Respondent”) is a nonresident insurance producer holding license #33309440 since January 31, 2018;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner of the Indiana Department of Insurance (“Commissioner”) with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on June 24, 2019, the Commissioner mailed Respondent a letter requesting a list of appointments via USPS First Class Mail to Respondent’s address of record;

WHEREAS, this letter was not returned to the Commissioner as “undeliverable” or otherwise;

WHEREAS, on July 10, 2019, the Commissioner mailed Respondent a certified mail article # 7005 3110 0002 4441 8495 requesting a list of appointments to Respondent’s address of record;

WHEREAS, on July 22, 2019, certified mail article # 7005 3110 0002 4441 8495 was returned to the Department which was marked as “Return to sender, Refused, Unable to forward”;

WHEREAS, Indiana Code § 27-1-15.6-7(h) states, in part, that a producer shall inform the Commissioner of a change of address not more than thirty (30) days after the change;

WHEREAS, Indiana Code § 27-1-15.6-12(b)(17) provides that the Commissioner may suspend an insurance producer's license for failing to timely inform the Commissioner of a change in address in violation of Indiana Code § 27-1-15.6-7(h);

WHEREAS, Respondent has failed to provide a change of address to the Commissioner within thirty (30) days after the change;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days and failure to provide a change of address within thirty (30) days after the change constitutes a violation of Indiana Codes §§ 27-1-15.6-12(g) and 27-1-15.6-12(b)(17); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license #3309440 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
