MOTION TO LIFT SUSPENSION ORDER


The Indiana Department of Insurance Enforcement Division (“Department”), by counsel, Erica J. Dobbs, now moves that the Suspension Order of June 7, 2019 be lifted. In support of this request the Department asserts the following:

1. Theona Songster-Anglin (“Respondent”) is a nonresident insurance producer holding license #3428205.
2. On May 10, 2019, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a letter requesting a list of appointments.
3. More than ten (10) days elapsed after the Commissioner requested a list of appointments without a response from Respondent.
4. Pursuant to Indiana Code §27-1-15.6-12(g), on June 7, 2019, the Commissioner issued a Suspension Order suspending Respondent’s license until such a time as the Commissioner received Respondent’s list of appointments.

5. On October 10, 2019, Respondent sent an email to the Department providing a list of her appointments.

WHEREFORE, the Department requests that the Commissioner issue an order lifting the suspension of Respondent's license and all other relief just and proper upon the premise.

FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS Theona Songster-Anglin (“Respondent”) is a nonresident insurance producer holding license number 3428205;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request, within ten (10) days of receiving a request;

WHEREAS, on April 17, 2019, the Commissioner of the Indiana Department of Insurance (“Commissioner”) mailed Respondent a letter requesting a list of appointments to Respondent’s address of record;

WHEREAS, on May 10, 2019, a second letter requesting a list of appointments was mailed to Respondent at Respondent’s address of record;

WHEREAS, neither letter has returned to the Department as “undeliverable;”

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner’s request;


WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days constitutes a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in his sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 3428205 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
